Privacy policy

Leigh Dumpleton Herbalism ("Leigh Dumpleton") is committed to protecting your privacy. This Privacy Policy applies to the Leigh Dumpleton Herbalism website and associated social media platforms, written documentation and information provided verbally and governs data collection and usage. By using Leigh Dumpleton's sites you consent to the data practices described in this statement.

1. COLLECTION OF YOUR PERSONAL INFORMATION

Leigh Dumpleton collects and stores personal information from and about you including but not limited to name, email address, home or work address, billing or payment information, health information and other personal information.

When a consultation is provided to you this will be done in a private space, including when a consultation is undertaken online. You should confirm the privacy of your own space when making an at-home appointment.

This information is collected in order to provide you with professional Medical Herbalist services including but not limited to, health assessment, health recommendations, prescriptions services, managing appointments, managing appointment payments and managing website services. Leigh Dumpleton may also use this information to provide users with ongoing support, maintain quality of services, provide general statistics regarding the use of the website, and comply with all and any applicable laws and regulations.

2. USE OF PERSONAL INFORMATION

Leigh Dumpleton collects and uses your personal information to operate the Leigh Dumpleton website and deliver services you have requested. Leigh Dumpleton may also use your information to inform you of other products or services available from Leigh Dumpleton. Providing your personal information to Leigh Dumpleton is voluntary. If you chose not to provide health and personal information to Leigh Dumpleton it may affect the services provided to you.

Any information you disclose to Leigh Dumpleton will be done so with your explicit consent at the time of disclosure, through written and verbal means. Your information is private and confidential and will never be shared without your consent. Leigh Dumpleton does not sell, rent or lease it's customers information to third parties.

- 3. SECURITY OF YOUR PERSONAL INFORMATION

Leigh Dumpleton secures your personal information from unauthorised access, use or disclosure. Leigh Dumpleton secures the personally identifiable information you provide on computer and mobile servers using Cliniko, and keeping secure electronic devices, in a controlled, secure, environment, protected from unauthorised access, use or disclosure.

Your information is kept safe and also stored securely with third party service providers, including but not limited to the following'

- a) the dispensary service *Mypatient Ordering* through Integria, in order to provide you with herbal prescription services;
- b) New Zealand Post, to ship any purchased prescribed items to you;
- c) Stripe, for processing online payments.

Your information is stored and/or transferred electronically with these service providers in order to manage client bookings, appointments, prescriptions, communications, payments and in the management of client health and treatment notes. Other electronic platforms in which your information may be collected and used for the above stated purposes include Facebook and Instagram, and over telecommunications connections including telephone. Information you provide to Leigh Dumpleton in the engagement and provision of telehealth video and/or audio calls is facilitated through the Cliniko platform and is transferred via secure end-to-end, peer-to-peer encryption methods. No personally identifying information is transmitted during a telehealth consultation. Any physical notes Leigh Dumpleton may take about information you disclose to Leigh Dumpleton is transferred to the Cliniko client management system and any physical notes are then destroyed securely.

Please refer to the individual Privacy policies of third-party service providers for more information about how these companies use, collect and store your information.

Your information will be kept for as long as it is needed for its intended purpose, all information will be held for a minimum of one year after the date of your last engagement with the service, after this date your information may be securely erased. Your information is retained for up to a year so your personal information will not need to be collected again if you decide to re-engage.
